3.1 OWNERSHIP:

1. THE SELLER GUARANTEES THAT IS THE TRUE AND LAWFUL OWNER OF THE ABOVE-DESCRIBED VEHICLE AND THAT THE VEHICLE IS FREE AND CLEAR OF ALL LIENS AND ENCUMBRANCES AND THAT THE TITLE IS CLEAN AND NOT SALVAGE.

3.2 WARRANTY:

1. THE SELLER WARRANTS THAT AT THE DATE OF SIGNATURE OF THIS AGREEMENT THERE ARE NO LICENSING FEES FINES OR OTHER PENALTIES OUTSTANDING AGAINST THE REGISTRATION OF THE VEHICLE SOLD IN TERMS OF THIS AGREEMENT.

3.3 CLAUSES:

1. THAT ALL PARTIES LISTED ON THE TITLE ARE OF MAJORITY AGE AND HAVE EXECUTED THE SIGNATURES NEEDED TO VALIDATE THE SALE.
2. THE SELLER CERTIFIES THAT THE ODOMETER READING OF THIS VEHICLE IS CORRECT TO THEIR KNOWLEDGE AND THAT THE SELLER HAS NOT MODIFIED THE ODOMETER, DISCONNECTED IT, OR ROLLED BACK THE MILEAGE DURING THEIR OWNERSHIP.
3. SELLER CERTIFIES THAT THE TITLE WILL BE TRANSFERRED TO THE BUYER AT THE TIME OF THE FINAL TRANSACTION.

4. THE SELLER IS TO HAND OVER THE KEYS, REMOTE CONTROLS, OWNER'S MANUAL, AND OTHER DOCUMENTS THAT ARE RELATED TO THIS VEHICLE, WHERE AVAILABLE, TO THE BUYER.

 5. THE SELLER IS TO PRESERVE THE CONDITION OF THIS VEHICLE AS OF THE DATE OF THIS AGREEMENT AND WITH ALL ACCESSORIES INTACT.

 6. THIS AGREEMENT CONSTITUTES THE ENTIRE AGREEMENT OF THE PARTIES RELATING TO THE SUBJECT MATTER ADDRESSED IN THIS AGREEMENT. THIS AGREEMENT SUPERSEDES ALL PRIOR COMMUNICATIONS, CONTRACTS, OR AGREEMENTS BETWEEN THE PARTIES WITH RESPECT TO THE SUBJECT MATTER ADDRESSED IN THIS AGREEMENT, WHETHER ORAL OR WRITTEN.

 7. IN THE EVENT OF A BREACH OF THIS AGREEMENT BY THE SELLER, THE SELLER IS TO COMPENSATE THE BUYER THE FULL AMOUNT OF THE DEPOSIT.

 8. THE BUYER IS TO PURCHASE AT HIS OWN EXPENSE, A MOTOR INSURANCE POLICY FOR THIS VEHICLE WHICH IS VALID AS OF THE DATE OF OWNERSHIP TRANSFER AND FOR NOT LESS THAN THE FULL PERIOD OF VALID ROAD TAX.

4. TRANSFER OF OWNERSHIP AND COSTS:

 2. THE VEHICLE WILL BE FULLY INSURED BY THE SELLER DURING SHIPPING.

6. 30 DAYS MONEY-BACK GUARANTEE:

1. OUR COMPANY GUARANTEES 30 DAYS INSPECTION PERIOD. THE INSPECTION PERIOD BEGINS ONCE THE VEHICLE IS DELIVERED. THIS MEANS THAT THE BUYER CAN REJECT THE CAR FOR ANY REASON DURING THE 30 DAYS OF INSPECTION AND GET THE FULL AMOUNT BACK.
 2. THE BUYER WILL BE REIMBURSED IN FULL, INCLUDING SHIPPING COSTS, FEES AND TAXES.
 3. ALL THE MODIFICATIONS THAT ARE REQUIRED FOR THE EUROPEAN ROADS WILL BE DONE BY THE SELLER, ALONG WITH THE RECALL CLEARANCE LETTER FROM ***** AND COC DOCUMENTATION, ORIGINAL CERTIFICATE OF TITLE OF VEHICLE (OR INTERNATIONAL CERTIFICATE FOR THE CAR WITH VALID DATE DELIVERY BY US ADMINISTRATION).
